WHAT TO BRING EACH DAY

 - Female volunteers must also wear swim shorts (such as biker shorts or dance/ gymnastics shorts) over a one-piece bathing suit or appropriate undergarments and the provided swim shirt
- Towel
- Water shoes
- Sunscreen

VOLUNTEER GUIDELINES

- · Smoking, drinking, and illegal substances are not allowed and will result in dismissal
- In case of emergency, find your group leader immediately. Emergencies may include:
 - ♦ Fire
 - ♦ Stranger on site
 - Missing participant
 - ♦ Injury or illness (only staff may administer first aid)

DO'S AND DON'TS



Do

- · Arrive between 9:00 and 9:15 AM
- Sign in and check in with your group teacher
- Keep your participant's items labeled and organized
- Supervise your participant attentively
- · Join and enjoy pool time with your participant
- · Hide your phone while you are at the pool
- · Ask staff or therapists if you need help
- Direct any concerns about a participant to staff or therapists, not parents
- Escort participants to the restroom when needed
- Treat all participants, staff, and volunteers with kindness and respect
- · Have fun and make memories!



- · Be late without notifying staff
- Leave without informing your group teacher
- · Use your phone while supervising a participant
- · Post any photos or videos of participants or staff online
- · Give your participant food without checking with your group teacher
- · Leave your participant sitting alone
- Use your phone while you are at the pool
- Ever use physical force or unkind words with participants. This is strictly prohibited
